#### **TAYLOR SCHMIDT:**

Introduced himself as the new Principal for Raymond Grade School. He looks forward to working with the Town officials.

# JULIA – a woman on 92<sup>nd</sup> Street:

Asked who mows the ditches in the Town?

It was said that the Town's DPW employees will mow twice a year, possibly 3 times; they will maintain 33 feet back from the center line.

### **SHARON KORPONAL:**

Asked Mr. Wanggaard a few questions; she asked how long will Highway "K" be closed? She asked about the extra money per student that the schools will be receiving from the State.

Mr. Wanggaard stated that he believes Highway "K" will be closed in October – it could be a complete closure.

As far as the extra money per student – the schools will received \$204.00 extra, for each student. This also included open enrollment students.

Sharon asked if any of the Board members received an invitation for Wing Span? She was told "none of them did".

# Dan Oakes:

Stated that Ms. Michel really does have a water problem. However, the water is not coming from his property (development) – it is coming from the reconstruction project for I94. He stated that he is now between Phase 2 and Phase 3.

The entrance will be off of the frontage road.
