In Person

Tax Payments will be accepted in person Monday through Friday, 9:00 am to 3:00 pm AND as follows:

Saturday hours: Saturday, December 18 & January 22, 9:00 am-12:00 pm

Evening hours: Wednesday, December 29, 5:30-8:00 pm

Thursday, January 27, 5:30-8:00 pm

NOTE: VILLAGE HALL IS CLOSED DECEMBER 23-24 AND 30-31 FOR THE HOLIDAYS

Payments in the drop box before 9 am on Monday, January 3, 2022 will be dated December 31, 2021

Payment Information:

- **Checks** should be made payable to VILLAGE OF RAYMOND
- **Payment stub** from your tax bill should be included with all payments
- **Mail/drop box payments:** If you want a **receipt** please include a self-addressed stamped envelope. No paperwork will be mailed without a stamped self-addressed envelope.
- **Overpayments:** No refunds will be issued at the time of payment. Refunds will be sent in the mail by check after the payment has cleared the bank (approximately 10 days).

Payment Deadlines:

NOTE: The Village of Raymond cannot accept real estate tax payments after the January 31st grace period ends. After that time, ALL real estate taxes must be made payable and sent to Racine County Treasurer, including late payments and the 2nd installment. (For late or 2nd Installment payments, if paying online through ACI, enter "Racine County" as the entity and "Real Estate Taxes" for payment type.)

Lottery Credit Information:

You are only entitled to one Lottery Credit – on your principal residence as of January 1 of the tax year. (If you have multiple parcels please check to make sure you are receiving only ONE Lottery Credit.) If you DO NOT see a Lottery Credit on your bill and think you should have one, please call or ask when paying your bill. We are able to issue late credits.

Cut along line, fill out and bring to Village Hall or mail in with self-addressed stamped envelope. Please do not mail cash.

DOG LICENSING:

State Statutes and Village Ordinance requires all dogs be licensed annually. A copy of your current rabies certificate and fee must be included for each dog. No license can be issued without a rabies certificate.

Fees: *Neutered/Spayed Fee - \$10.00 Unaltered Fee - \$15.00 Late Fee: - \$5.00 (after March 31st)*
